There are two options for cor	npleting this form.					
<u>Option 1:</u> You must appear in person at the Office of Financial Aid to present your identity documents and sign the Statement of Educational Purpose.						
Option 2: If you are unable to appear in person, you must go to a notary public to sign this form and present your identity documents. The notary will verify that you appeared before them to complete this process and fill out the Certification of Acknowledgement. You will submit this form with the original wet signatures and your identity document.						
OPTION 1: TO BE COMPLETED AND SIGNED AT OCCIDENTAL OFFICE OF FINANCIAL AID						
The student must appear in person at Occidental College's Office of Financial Aid to verify his or her identity by presenting an unexpired valid government-issued photo identification (ID), such as, but not limited to, a driver's license, other state-issued ID, or passport. The institution will maintain a copy of the student's photo ID that is annotated by the institution with the date it was received and reviewed, and the name of the official at the institution authorized to receive and review the student's ID. In addition, the student must sign, in the presence of the institutional official, the Statement of Educational Purpose provided below.
